

Ashton Green is a major sustainable urban extension for Leicester. Projected to have 3,000 homes, a commercial village centre and 55 acres (22 ha) of employment land. Development is well underway with around 265 homes occupied (Phases A&B), a developer appointed for Phase C, and the tender process for Phases D&E underway. Ashton Green is in a superb location with good access to the city centre, the strategic road network, and within easy reach of some of the county's finest countryside and villages. There are a number of established businesses operating in close proximity to the Ashton Green site. These include Samworth Brothers , PepsiCo, DHL, Trelleborg, Marks Electrical, Viking Office UK Limited, Mertrux Limited, Sweet Cherry Publishing & Walkers.
